# BJP declared building a Ram temple there as its political objective

Built by Mirbahi four hundred and fifty years ago, the Babri Masjid in Ayodhya continues to be a place of worship for Muslims. In December 1949, Hindu organizations tried to claim that Lord Rama was born in the corridors of the Babri Masjid. In turn Babri Masjid has become a controversial subject. Starting with court cases, the Bharatiya Janata Party declared building a Ram temple there as its political objective. For that, they gathered thousands of people under the guise of service and demolished the Babri Masjid. In this regard, the judgment given in the Supreme Court said that the demolition of the Babri Masjid is a criminal offence. But at the same time, the Supreme Court gave permission to build a Ram Temple on the site where the Babri Masjid was demolished. This verdict came as a shock to those who have faith in the court and the minority community. But the



minority people who wanted peace remained silent without any protest against the verdict. This showed their tolerance. Following this, a Ram temple was recently built there during the Narendra Modi regime, and Kodamuzku was held there. In this case, the National Institute of Educational Research and Training has completely removed references to Babri Masjid from the curriculum for students. This is a blatant cover up of historical traces. The National Democratic Alliance government thinks that Babri Masjid can be removed from history by removing it like this. Through this, it has been confirmed that there is no change in the attitude of the BJP government and the NDA government against the minorities. ## Central Excise duty on petrol was Rs 9.48 per litre and Rs 3.56 on diesel before BJP came to power

The Government of Karnataka has increased VAT on petrol to 29.84% and on diesel to 18.44%. Even after this hike, our state's taxes on fuel remain lower than most South Indian states and similar economysized states like Maharashtra.In Maharashtra, the VAT on petrol is 25% plus Rs 5.12 additional tax, and on diesel, it is 21%. Karnataka's revised rates are still more affordable. Despite the VAT hike, diesel prices in Karnataka are still lower than in Gujarat and Madhya Pradesh. We remain committed to keeping fuel prices reasonable for our citizens. The then Double Engine BJP government collab-

orated to divert Karnataka's resources to other states. The state BJP govt kept reducing VAT on petrol and diesel while the Central govt increased its own taxes.This manipulation led to reduced revenue for Karnataka, while the Central government collected more for its cof-

fers, cheating Kannadigas.Central Excise duty on petrol was Rs 9.48 per litre and Rs 3.56 on diesel before BJP came to power in 2014. However during the tenure of **BJP** Government, the Central Excise Duty on Petrol and Diesel was steeply

increased reaching to a record high of Rs 32.98 and Rs 31.83, respectively, in May 2020. Subsequently, the Excise duty on petrol and diesel was cut by Rs 13 a litre and Rs 16, respectively, between November 2021 and May 2022. Despite the reductions, the current central excise duty on petrol is Rs 19.9 and on diesel is Rs 15.8. We urge the Union Government to reduce these taxes for the benefit of the people. Karnataka's VAT adjustment ensures we can fund essential public services and development projects. The state remains committed to balanced and responsible governance.
