

Congress Chief's 'Double Standards' Jibe At Centre On Rahul Gandhi's Disqualification

New Delhi: Congress president Mallikarjun Kharge today accused the Centre of double standards, saying while it disqualified Rahul Gandhi with lightning speed, a Gujarat MP who was convicted in a criminal case did not face the same action.

Mr Kharge was referring to the BJP's Amreli MP Naranbhai Bhikhabhai Kachhadia, who was awarded a three—year jail term by a court. Kachhadia's conviction was later quashed by the Supreme Court.

Mr Gandhi was convicted by a lower court in Gujarat's Surat and sentenced to prison for two years on March 23 for a speech in which he linked Prime Minister Narendra Modi's last name with two fugitive businessmen, remarking how the "thieves" shared the same last name.

A day later, he was disqualified as a member of the Lok Sabha.


Mr Kharge said the Gujarat MP was allowed to attend the Parliament but a person who speaks the truth has been kept out of Parliament.

Congress leader in Lok Sabha Adhir Ranjan Chowdhury has also written to Speaker Om Birla seeking a discussion on Gandhi's disqualification.

A sessions court in Surat on April 3 granted bail to Gandhi and will hear on April 13 his plea for a stay of his conviction in the 2019 criminal defamation case.
