A one-man committee headed by retired Justice Sanduru was formed to create social harmony in educational institutions after two scheduled students were assaulted by other community students at a school in Nanguneri in August last year. The committee submitted its report on June 18 last month to Tamil Nadu Chief Minister M.K. Stalin submitted to them. Its recommendations appeared in the media. Commenting on this, Tamil Nadu BJP. President Annamalai has personally issued a venomous comment to Judge Sanduru saying that he should join the DMK and become the Policy Propagation Secretary instead of sitting in the committees formed by the government for his own profit and submitting the policies of the DMK as a report with the people's tax money. I strongly condemn this on behalf of the Tamil Nadu Congress. Everyone knows the reasons why Annamalai is angry with Justice Sanduru. According to Justice Sanduru, he was a student at the age of 17 when 44 downtrodden people were set on fire and murdered in Kilivenmani in 1968 and he raised his voice and fought for justice. When he started his career as a lawyer in 1976, he focused on labor welfare and rights related cases. He has the honor of arguing in court in cases of depriving people of their rights without receiving any professional fee. He advocated for the affected people with social consciousness in all the public interest cases, human rights cases, women's rights cases. In 2006 he took charge as a judge of the Madras High Court based on his sincere commitment to the legal profession. He has made a record of ruling in approxi-



mately 90,000 cases. He has given judgments in all cases with social thinking and concern. Among the judgments passed were judgments which established the rights of women to be worshiping gurus in temples, one cremation for all without caste discrimination, right to worship in temples for the downtrodden, caste and religious disobedience marriages and measures to restore panchami lands and give them to the Scheduled Castes with a social consciousness, judgments for the oppressed people for social equality. He made history by giving and getting rights. Dr. P.R. was the legal maverick

inclusive Indian Constitution for the people of India. He implemented Ambedkar's principles as a judge with great courage. He lived as a fighter defending the features of the Constitution. Justice Sanduru, who has such historical honors, has no reason to criticize Annamalai who has a fascist tendency. Annamalai is an anti-Tamil who openly spoke on the stage as a police officer in the state of Karnataka and said that he would only speak for the Kannada people and not for the Tamils who belong to him. Tamil Nadu BJP After joining the party, a person who contested the assembly elections and lost miserably, got promoted and became the state president, it is a curse for Tamil Nadu BJP. He has succeeded in marginalizing all those who have been leading leaders for a long time in Tamil Nadu rather than the care he shows in developing the BJP in Tamil Nadu. By this he is digging a hole and burying the BJP. He is doing sensational politics by spreading slanderous mud on anyone including Justice and thereby gaining media attention. I am obliged to remind Annamalai that those who practiced such politics in the past were pushed into the abyss. It is well known that serious conflicts have occurred in the past due to the breakdown of law and order and violent frenzy in educational institutions due to expression of caste, religion and sentiments. Social, social , In such a way that concepts related to equality are given place, it is emphasized that morality classes should be held weekly and recommendations were given that educational institutions should teach with general social consciousness and not to promote diversity among students through caste symbols. It is not wrong to discuss the statement given by Justice Sanduru on the ground that such marks do not in any way help in developing academic knowledge. However, Annamalai should immediately stop making baseless accusations by instructing Judge Sanduru who gave the report. The Sri Lankan Navy has been arresting the fishermen of Tamil Nadu

The Sri Lankan Navy has been arresting the fishermen of Tamil Nadu who have gone fishing after the fishing ban, confiscating the boats, filing cases and imprisoning them. In this way, four fishermen and 1 boat from Kottapattinam on 18th June, 22 fishermen and 3 boats from Rameswaram on 23rd June, 10 fishermen and 1 boat from Nagapattinam on 26th June, 25 fishermen from Pamban and Nambuthalai on 1st July and 4 country boats, 3 boats and 13 fishermen from Kottapattinam and Jagadapattinam on July 4, 74 fishermen have been arrested so far and 4 country boats and 8 boats have been seized by Sri Lankan government. Fishermen's organizations have

been protesting several times to

demand the release of fishermen

who have been arrested by the

Sri Lankan Navy for fishing and

have already been centenced to

have already been sentenced to one year, two years and 6 months in prison.India-Sri Lanka on the traditional Kachchathivu area where the National Democratic Alliance government is demanding appropriate compensation, as the Tamil Nadu government is demanding the release of more than 170 barges and country boats of Tamil Nadu fishermen in possession of the Sri Lankan Navy from 2018 to 2024. A massive protest demon-

stration is going to be held near Rameswaram Bus Stand on 19.7.2024 on Friday 19.7.2024 on behalf of Traditional Indian Fishermen Welfare Association, demanding the Union Government to provide a way for fishermen to fish without any problem.
